THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the NORTH 224 Lode Mining Claim on this 12th day of October, 1987, situated in the Unknown Mining District, Eureka County, Nevada.
