 West direction and 20 feet in a East direction from the location monument, at
 on each side of the center of the claim. The general course of the lode deposit and premises is from

 Corner No. 5 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
 Corner No. 6 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.

The monumentation and marking of the corners was completed by the 11th day of
 October, 1987.
