

Certificate of Location of Lode Mining Claim

The claim is 1450 feet long and 550 feet wide, and 1430 feet is claimed in a West direction and 20 feet in a East direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 275 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Aluminum tags.

Corner No. 1 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.

Corner No. 3 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
Corner No. 4 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
Corner No. 5 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
Corner No. 6 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.

The monumentation and marking of the corners was completed by the 11th day of October, 1987.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
