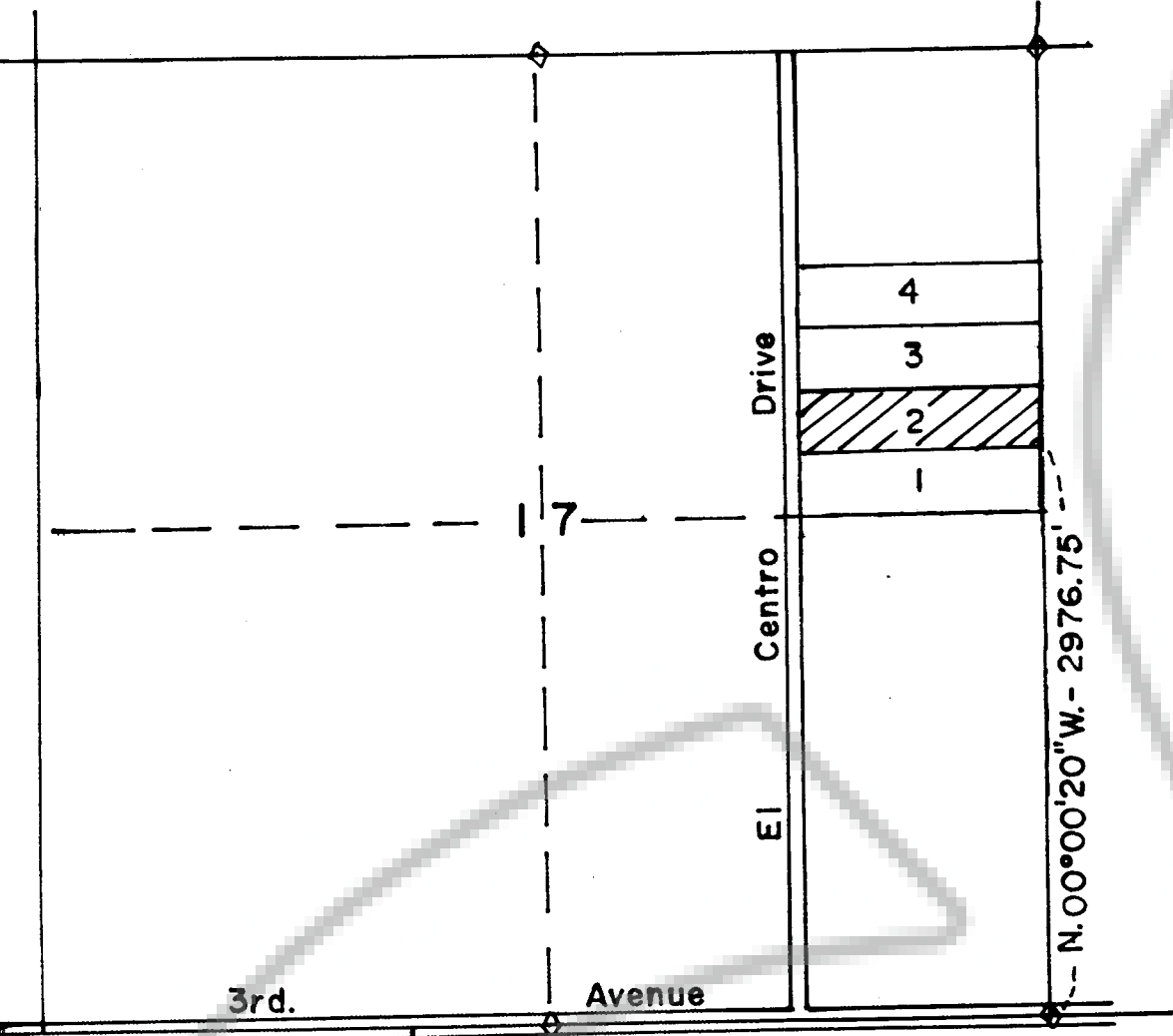
**NOTE**
