CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the WI 164A Lode Mining Claim on this 29th day of October, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE (Quarter) Section(s) 3, Township 22 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 50 feet in a south direction to Post No. 2, marked - WI 164A - 2
- Thence, 750 feet in a west direction to Post No. 3, marked - WI 164A - 3
- Thence, 750 feet in a west direction to Post No. 4, marked - WI 164A - 4
- Thence, 50 feet in a north direction to Post No. 5, marked - WI 164A - 5

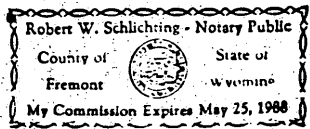
