NOTICE OF NONRESPONSIBILITY

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, in accordance with the provisions of Section 108.234 of the Nevada Revised Statutes, does hereby give notice that:

(a) Foreland Corporation, a Nevada corporation, 2668 Grant Avenue, Ogden, Utah 84401 ("Foreland"), has entered into a Farmout Agreement dated March 13, 1987 (the "Farmout Agreement"), with Alford Oil Corporation, a Texas corporation, 15919 Stuebner-Airline, Spring, Texas 77397 ("Alford"), whereby Alford is granted the right and option to drill test wells at its sole expense and liability upon those lands described on Exhibit A, attached hereto and by reference incorporated herein (the "Lands");

(b) Foreland will not be responsible for any costs, expenses or claims related to the construction, alteration or repair of any improvement upon the Lands, or for any oil and gas drilling activities conducted, or oil and gas equipment placed, upon the Lands by Alford or its operating affiliate, Dixie Operating Company, pursuant to the Farmout Agreement; and

(c) the Farmout Agreement expressly excludes designation of either party as agent or legal representative of the other, and excludes and disclaims the creation of any mining, commercial or other partnership between the parties.
