THE UNDERSIGNED, hereby certifies that **ATLAS PRECIOUS METALS INC.**, by its Agent, the undersigned, does hereby locate the **NORTH 67** Lode Mining Claim on this **8th** day of **August**, 1987, situated in the **Unknown** Mining District, **Eureka** County, Nevada.

 Thence, 750 feet in a S65°E direction to Post No. 6, marked - NORTH 67 - 6
 Thence, 750 feet in a S65°E direction to Post No. 1, marked - NORTH 67 - 1

the point of beginning and all posts being 3"X4' durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a N 65°W direction and 10 feet in a S65°E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N65°W and S65°E.
