CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that **ATLAS PRECIOUS METALS INC.**, by its Agent, the undersigned, does hereby locate the **NORTH 69** Lode Mining Claim on this **8th** day of **August**, 1987, situated in the **Unknown** Mining District, **Eureka** County, Nevada.

Said Claim is located in the **SW(SE)(NE)** (Quarter) Section(s) **21(21)(28)**, Township **25 North**, Range **50 East**, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 600 feet in a S25°W direction to Post No. 2, marked - NORTH 69 - 2
Thence, 750 feet in a N65°W direction to Post No. 3, marked - NORTH 69 - 3
Thence, 750 feet in a N65°W direction to Post No. 4, marked - NORTH 69 - 4
Thence, 600 feet in a N25°E direction to Post No. 5, marked - NORTH 69 - 5
Thence, 750 feet in a S65°E direction to Post No. 6, marked - NORTH 69 - 6
Thence, 750 feet in a S65°E direction to Post No. 1, marked - NORTH 69 - 1

the point of beginning and all posts being **3"X4'** durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is **1490** feet in a **N 65°W** direction and **10** feet in a **S65°E** direction, together with **300** feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is **N65°W** and **S65°E**.
