THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the NORTH 179 Lode Mining Claim on this 9th day of August, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a N 65°W direction and 10 feet in a S65°E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
