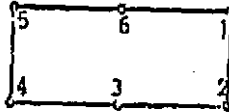

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the NORTH 196 Lode Mining Claim on this 28th day of September, 1987, situated in the (Unknown) Mining District, Eureka County, Nevada.

Said Claim is located in the NE (Quarter) Section(s) 10 Township 25 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>750</u> feet in a <u>S25°W</u> direction to Post No. 2, marked - <u>NORTH 196 - 2</u>
Thence, <u>750</u> feet in a <u>S25°W</u> direction to Post No. 3, marked - <u>NORTH 196 - 3</u>
Thence, <u>500</u> feet in a <u>N65°W</u> direction to Post No. 4, marked - <u>NORTH 196 - 4</u>
Thence, <u>750</u> feet in a <u>N25°E</u> direction to Post No. 5, marked - <u>NORTH 196 - 5</u>
Thence, <u>750</u> feet in a <u>N25°E</u> direction to Post No. 6, marked - <u>NORTH 196 - 6</u>
Thence, <u>500</u> feet in a <u>S65°E</u> direction to Post No. 1, marked - <u>NORTH 196 - 1</u>

the point of beginning and all posts being 3" X 4" durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a N25°E direction and 1490 feet in a S25°W direction, together with 250 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N25°E and S25°W.

To tie this Claim to the Public Survey, begin at the SE corner, Section 33, Township 25 N, Range 50 E, Mt. Diablo P.M., and bear N65°W, 7169 feet and N25°E, 24559 feet to the northeast corner of this Claim.
