CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 18 Lode Mining Claim on this 28th day of November, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(ESSE) (Quarter) Section(s) 9(4)(3), Township 19 North, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a S30°W direction to Post No. 2, marked - OLD YELLER 18 -2
Thence, 750 feet in a S30°W direction to Post No. 3, marked - OLD YELLER 18 -3
Thence, 600 feet in a N60°W direction to Post No. 4, marked - OLD YELLER 18 -4
Thence, 750 feet in a N30°E direction to Post No. 5, marked - OLD YELLER 18 -5
Thence, 750 feet in a N30°E direction to Post No. 6, marked - OLD YELLER 18 -6
Thence, 600 feet in a S60°E direction to Post No. 1, marked - OLD YELLER 18 -1

the point of beginning and all posts being 3" X 4" durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 50 feet in a S30°W direction and 1450 feet in a N30°E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is S30°W and N30°E.

To tie this Claim to the Public Survey, begin at the NW corner, Section 27, Township 20 N., Range 52 E., Mt. Diablo P.M., and bear S60°E, 4853 feet and S30°W, 11067 feet to the northeast corner of this Claim.

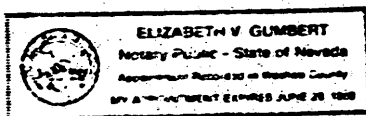
