4. The general course of the lode or vein, as near as may be determined, is East and West.5. The locator claims 20 feet in a Westerly direction and 1,480 feet in a Easterly direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.

8. The monumentation and marking of the monument on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of making and recording of duplicate claim maps filed herein and incorporated herein by this reference.
