THE UNDERSIGNED, hereby certifies that **ATLAS PRECIOUS METALS INC.**, by its Agent, the undersigned, does hereby locate the **OLD YELLER 31** Lode Mining Claim on this 14th day of January, 1988, situated in the Unknown Mining District, Eureka County, Nevada.
