CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 37 Lode Mining Claim on this 14th day of January, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW(SE) (Quarter) Section(s) 11(11) Township 19 North, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

 Thence, 600 feet in a south direction to Post No. 2, marked - OLD YELLER 37-2
 Thence, 750 feet in a west direction to Post No. 3, marked - OLD YELLER 37-3
 Thence, 750 feet in a west direction to Post No. 4, marked - OLD YELLER 37-4
 Thence, 600 feet in a north direction to Post No. 5, marked - OLD YELLER 37-5
 Thence, 750 feet in a east direction to Post No. 6, marked - OLD YELLER 37-6

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1425 feet in a east direction and 75 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
