CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 38 Lode Mining Claim on this 13th day of January, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 25 feet in a east direction and 1475 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
