## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 42 Lode Mining Claim on this 13th day of January, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(NW) (Quarter) Section(s) 15(14) Township 19 North, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Thence, 750 feet in a west direction to Post No. 4, marked - OLD YELLER 42-4

Thence, 750 feet in a east direction to Post No. 6, marked - OLD YELLER 42-6  
Thence, 750 feet in a east direction to Post No. 1, marked - OLD YELLER 42-1

the point of beginning and all posts being 4" wood or cut and marked trees.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 15 feet in a east direction and 1485 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.

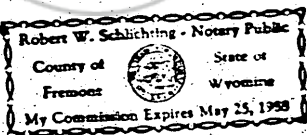
