Thence, 750 feet in a west direction to Post No. 4, marked - OLD YELLER 56 - 4
Thence, 600 feet in a north direction to Post No. 5, marked - OLD YELLER 56 - 5
Thence, 750 feet in a east direction to Post No. 6, marked - OLD YELLER 56 - 6
Thence, 750 feet in a east direction to Post No. 1, marked - OLD YELLER 56 - 1

the point of beginning and all posts being 4" wood or cut and marked trees.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1450 feet in a east direction and 50 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.


