the point of beginning and all posts being 4" wood or cut and marked trees

The number of linear feet claimed in length along the course of the vein from the point of discovery is 15 feet in a east direction and 1485 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.


