The number of linear feet claimed in length along the course of the vein from the point of discovery is 1475 feet in a east direction and 25 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

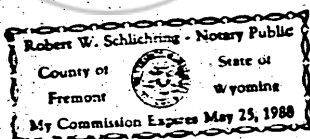
