CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 62 Lode Mining Claim on this 13th day of January, 1988, situated in the Unknown Mining District, Esmeralda County, Nevada.
