CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 95 Lode Mining Claim on this 14th day of January, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(NW) (Quarter) Section(s) 23(24) Township 19 North, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a south direction to Post No. 2, marked - OLD YELLER 95-2
- Thence, 750 feet in a west direction to Post No. 3, marked - OLD YELLER 95-3
- Thence, 750 feet in a west direction to Post No. 4, marked - OLD YELLER 95-4
- Thence, 600 feet in a north direction to Post No. 5, marked - OLD YELLER 95-5
- Thence, 750 feet in a east direction to Post No. 6, marked - OLD YELLER 95-6
