1. They are all of the original incorporators of the above named corporation, BRISTLECONE, INC., whose original Articles of Incorporation were filed in the office of the Secretary of State of the State of Nevada on April 28, 1987, and in the office of the County Clerk of the County of Elko, State of Nevada, on April 30, 1987.

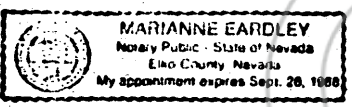

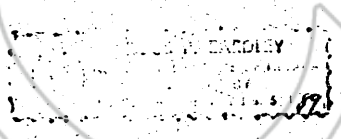

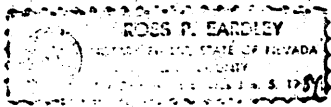
