The claim is 1000 feet long and 600 feet wide, and 25 feet is claimed in a EAST direction and 1475 feet in a WEST direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the EAST to the WEST.

The monumentation and marking of the corners was completed by the 22 day of DECEMBER, 1987.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
