To tie this claim to the Public Survey, begin at the Southwest Corner of
Section 22, Township 30 N., Range 49 E., Mount Diablo Base and Meridian,
thence North, approximately 2946 feet and East, approximately
4720 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,480 linear feet along the course of the mineral-bearing
ledge, lode or vein, extending 1,470 feet from the location monument in a
Northerly direction and 10 feet in a Southerly direction, together with
295 feet on each side of the center of the ledge for the entire length of the
claim.

The exterior boundaries of this claim are clearly marked by substantial
3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing
applicable monument designation. The description of such claim is:

the point and place of beginning.

The monumentation and marking of the corners was completed by the 20th day of
December, 1987.
