We (or I) claim 1,680 linear feet along the course of the mineral-bearing
ledge, lode or vein, extending 1,470 feet from the location monument in a
Northerly direction and 10 feet in a Southerly direction, together with a
295 feet on each side of the center of the ledge for the entire length of the
claim.

The exterior boundaries of this claim are clearly marked by substantial
3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing
applicable monument designation. The description of such claim is:
