THIS IS TO CERTIFY that the HSP No. 33 lode mining claim was located by:

We (or I) claim 1,480' linear feet along the course of the mineral-bearing  
ledge, lode or vein, extending 1,470 feet from the location monument in a  
Northerly direction and 10 feet in a Southerly direction, together with  
295 feet on each side of the center of the ledge for the entire length of the  
claim.

The exterior boundaries of this claim are clearly marked by substantial  
3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing
