THIS IS TO CERTIFY that the HSP No. 45 lode mining claim was located by:

Eureka County, State of Nevada.

Said claim is located in the following 1/4 section(s):

- NW 1/4 of Section 20, Township 30 N., Range 49 E., M.D.B. & M.
- NE 1/4 of Section 20, Township 30 N., Range 49 E., M.D.B. & M.
- SE 1/4 of Section 20, Township 30 N., Range 49 E., M.D.B. & M.
- SW 1/4 of Section 20, Township 30 N., Range 49 E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 20, Township 30 N., Range 49 E., Mount Diablo Base and Meridian, thence North, approximately 2,657 feet and East, approximately 2,356 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,177 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,167 feet from the location monument in a Northerly direction and 10 feet in a Southerly direction, together with 295 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

- thence, S.90°00'00"E., 590.0 feet to the Northeast Corner (Cor. No. 2),
- thence, S.00°11'37"E., 588.5 feet to the East Side Center (Cor. No. 3),
- thence, S.00°11'37"E., 588.5 feet to the Southeast Corner (Cor. No. 4),
- thence, N.90°00'00"W., 590.0 feet to the Southwest Corner (Cor. No. 5),
- thence, N.00°11'37"W., 588.5 feet to the West Side Center (Cor. No. 6),
- thence, N.00°11'37"W., 588.5 feet to the Northwest Corner (Cor. No. 1), the point and place of beginning.

The monumentation and marking of the corners was completed by the 20th day of December, 1987.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
