thence South, approximately 1,494 feet and West, approximately
1,858 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,480 linear feet along the course of the mineral-bearing
ledge, lode or vein, extending 1,470 feet from the location monument in a
Southerly direction and 10 feet in a Northerly direction, together with
46 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial
3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing
applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, N.89°34'00"E., 92 feet to the Northeast Corner (Cor. No. 2),

thence, S.00°08'05"E., 740 feet to the East Side Center (Cor. No. 3),

thence, S.00°08'05"E., 740 feet to the Southeast Corner (Cor. No. 4),

thence, S.89°34'00"W., 92 feet to the Southwest Corner (Cor. No. 5),

thence, N.00°08'05"W., 740 feet to the West Side Center (Cor. No. 6),

thence, N.00°08'05"W., 740 feet to the Northwest Corner (Cor. No. 1),
the point and place of beginning.

The monumentation and marking of the corners was completed by the 20th day of
December, 1987.
