CERTIFICATE OF LOCATION

We (or I) claim 848 linear feet along the course of the mineral-bearing ledge,  
lode or vein, extending 838 feet from the location monument in a Southerly  
direction and 10 feet in a Northerly direction, together with 46 feet on  
each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial
