CERTIFICATE OF LOCATION OF LODE MINING CLAIM

THIS IS TO CERTIFY THAT, in accordance with the requirements of Title 30, United States Code, Section 28, and the local laws, customs, and regulations of this state, the DYC- 64 Lode Mining Claim was located by CYPRUS GOLD EXPLORATION CORPORATION, a Delaware corporation, on the 6 day of December, 1987.

The claim is 1500 feet long and 600 feet wide, and 1480 feet is claimed in a East direction and 20 feet in a West direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center line of the claim. The general course of the lode deposit and premises is from the East to the West.

The location and number of this claim is shown on the claim map that is filed herewith. Each corner and side center is defined on the ground by monuments with appropriate markings as follows: 3" x 5' white PVC Pipe Set 1' in ground with scribed metal tag. The monumentation and the marking of corners and side centers was completed by the 10 day of December, 1987.

The area covered by this claim is as follows:

Beginning at Monument No. 1, the Southeast corner, which is 1860 feet South and 75 feet East of Bench Mark 58301 in the NW 1/4 of the SW 1/4 of Section 28 T25N, R50E M.D.B. and M., thence Westerly 750 feet to Monument No. 2, the South Side Center, thence Westerly 750 feet to Monument No. 3, the Southwest Corner, thence Northerly 600 feet to Monument No. 4, the Northwest Corner, thence Easterly 750 feet to Monument No. 5, the North Side Center, thence Easterly 750 feet to Monument No. 6, the Northeast Corner, thence Southerly 600 feet to Monument No. 1, the point of beginning.

The work of location consisted of making a claim map as provided in N.R.S. 517.040. Two copies of this claim map have been filed with the County Recorder, and the filing fee has been paid to the County Recorder.
