Each corner and side center is defined on the ground by monuments with appropriate markings as follows: 3" x 5' white PVC Pipe Set 1' in ground with scribed metal tag. The monumentation and the marking of corners and side centers was completed by the 10 day of December, 1987.

The work of location consisted of making a claim map as provided in N.R.S. 517.040. Two copies of this claim map have been filed with the County Recorder, and the filing fee has been paid to the County Recorder.
