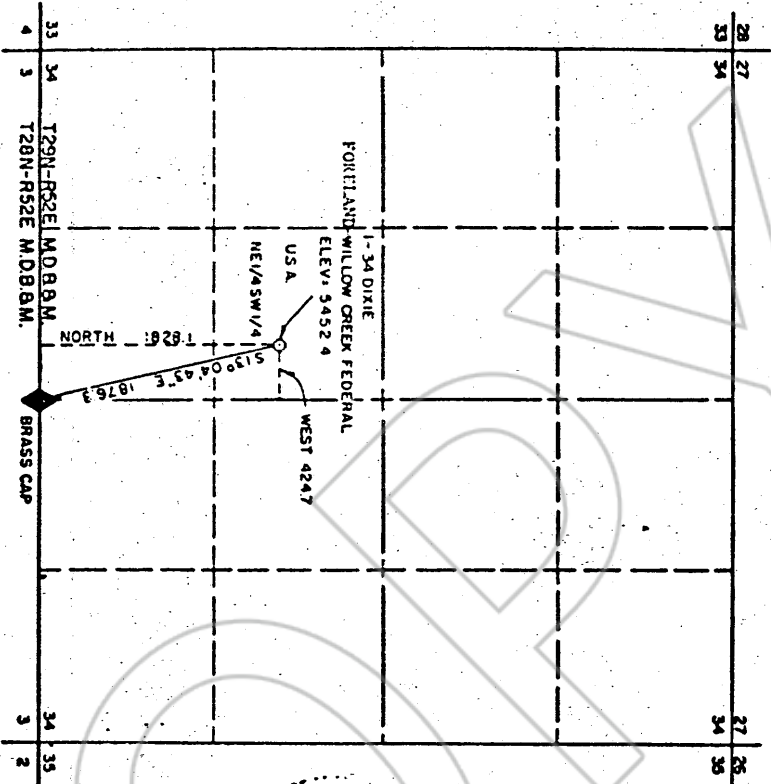

attached surveyor's land plat.

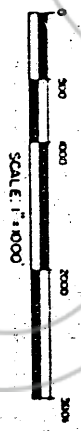
