DELBERT W. ROBINSON, administrator of the estate of

1988, rendered and filed herein a full account and report of his  
administration of said estate, which said account was for a final  
settlement and having with said account filed a petition for the  
final distribution of said estate, and, said account and petition  
this day coming on regularly to be heard and proof having been  
made to the satisfaction of the Court that the clerk had given  
notice of the settlement of said account and the hearing of said  
petition in the manner and time required by law.

1. THAT said account is in all respects true and  
correct and that there will be no further expenditures necessary  
in the closing of said estate.

1           2. THAT due and legal notice to creditors of said  
2 estate has been given in the manner and for the time required  
3 by law.

4           3. THAT all claims and debts against said estate;  
5 all taxes and debts, expenses and charges of administration have  
6 been fully paid and discharged and that said estate is now ready  
7 for distribution and now in a condition to be closed.

8           4. THAT since the rendition of said account no moneys  
9 have been received by administrator and no money has been paid  
10 on expenses or administration, and no further moneys must be  
11 expended in closing said estate.

12           5. THAT the whole of said estate is the community  
13 property interest of the decedent.

14           6. THAT the said ADAIR C. ROBINSON died intestate  
15 and left surviving her the following heir, who is entitled to the  
16 residue of said estate hereinafter described, remaining for dis-  
17 tribution:
