NOTICE OF MECHANICS AND MATERIALMEN'S LIEN

NOTICE IS HEREBY GIVEN pursuant to NRS Chapter 108:

1. Intention to Claim Lien. It is the intention of Lamb Engineering and Construction Company, ("Claimant") 125 Walton Avenue, Salt Lake City, Utah 84115 to claim and hold a lien upon that certain tract of land hereafter described.
