# CERTIFICATE OF LOCATION OF LODE MINING CLAIM

The general course of the lode deposit and premises is from the East to  
the West.

The location and number of each corner of this claim is shown on the claim map

appropriate number by marking the claim name and number on an aluminum tag.

The description of each corner is as follows:

- Northwest Corner No. 1 is a 3" x 4 foot PVC pipe.
- North side Center No. 2 is a 3" x 4 foot PVC pipe.
- Northeast Corner No. 3 is a 3" x 4 foot PVC pipe.
- Southeast Corner No. 4 is a 3" x 4 foot PVC pipe.
- South side Center No. 5 is a 3" x 4 foot PVC pipe.
- Southwest Corner No. 6 is a 3" x 4 foot PVC pipe.

The monumentation and marking of the corners was completed by the 16th day  
of February, 1988. This claim is intended to cover all land open to  
location existing within its boundaries as of this date of posting.

The location work consisted of making a claim map as provided in NRS 517.040.  
Two copies of this claim map have been filed with the Eureka County  
Recorder, and the required lode claim filing fee has been paid to the County Recorder.
