The claim is 1450 feet long and 200 feet wide, and 1430 feet is claimed in a West direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 100 feet in width on each side of the center of the claim.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number

by Aluminum tags.

- Corner No. 1 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
- Corner No. 2 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
- Corner No. 3 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
- Corner No. 4 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
- Corner No. 5 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.
- Corner No. 6 is a 5 foot long X 3 inch diameter white PVC pipe buried 1 foot deep.

This being the same lode originally located on the 24th day of September 1987, and recorded on the 13th day of November, 1987, in Book 168 Page 504, in the office of the Recorder of Eureka County. This further additional and amended certificate of location is made without waiver of any previously acquired rights, but for the purpose of correcting any errors in the original location, description or record, and of taking in and acquiring all forfeited or abandoned overlapping ground and of taking in any part of any overlapping claim which has been abandoned, and of securing all benefits of said statutes of Nevada.

The monumentation and marking of the corners was completed by the 11th day of October, 1987
