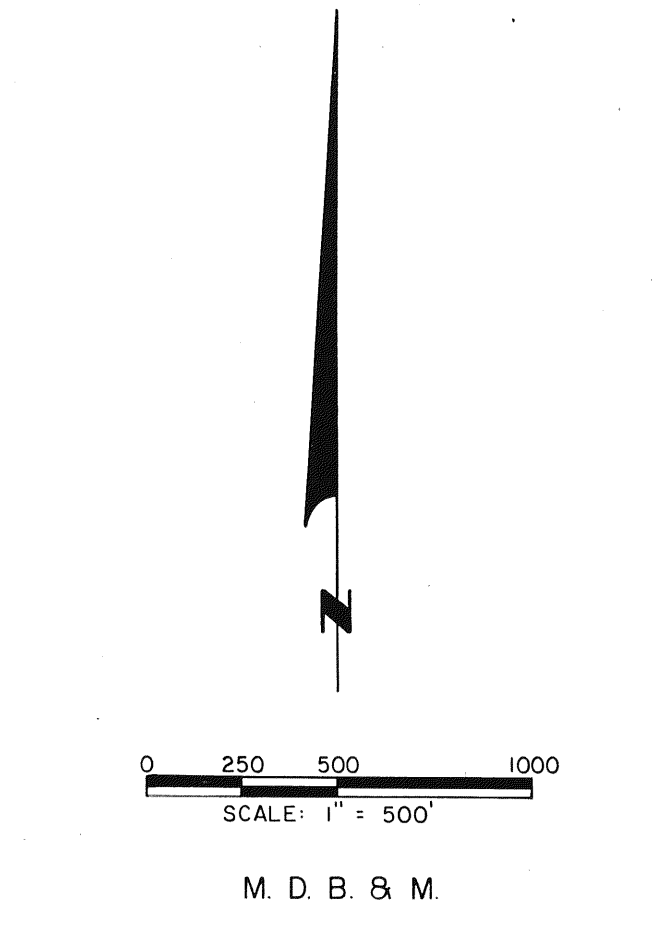
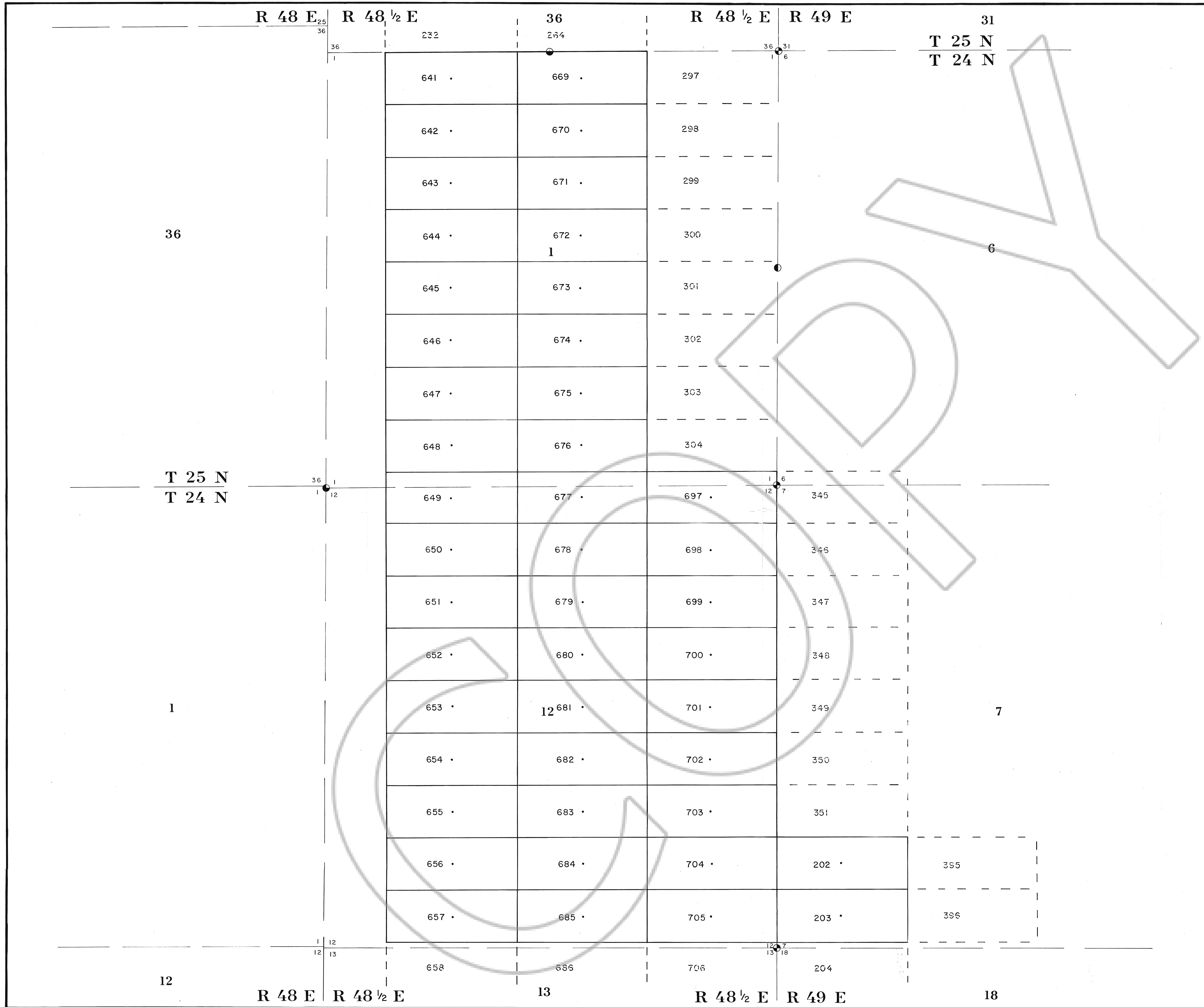
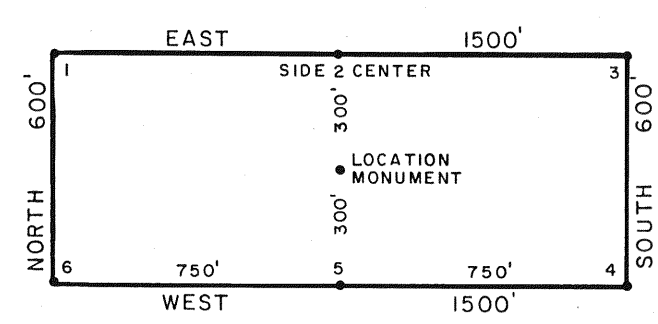




TYPICAL CLAIM & CORNER NUMBERS

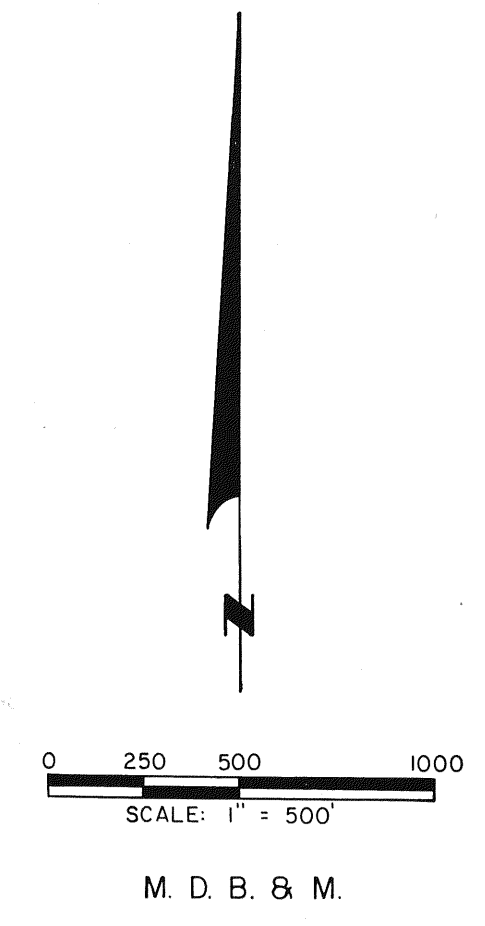

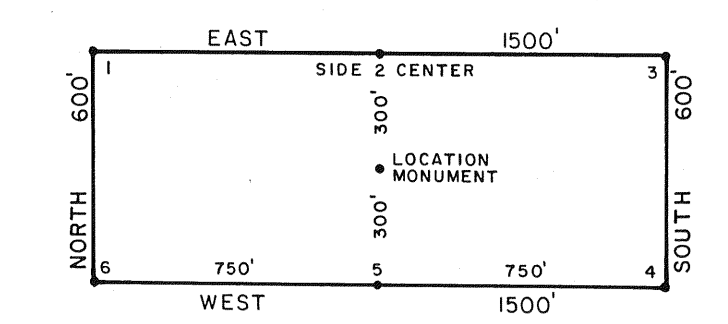
