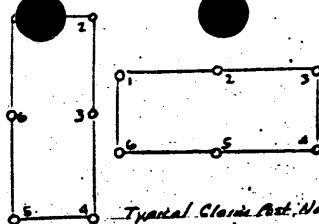

The General course of the vein, lode, deposit and premises as near as can be determined is North-South. The size of the claim is 1500 feet long by 600 feet wide and 1490 feet is claimed in a South direction and 10 feet is claimed in a North direction from the location monument on which the notice of location is posted together with 300 feet in width on each side of the center of the lode or vein.

The position of each corner of this claim and its number is shown on the claim map filed herewith and is by reference incorporated herein. On the ground each corner is marked with its appropriate number by permanent ink marker on white PVC pipe. The corners and monuments are White 3" PVC pipe five feet long and set one foot in the ground.

The monumentation and marking of the above described corners was completed within .60 days from the date of posting of the notice of location.

The location work consisted of making and recording of the aforesaid claim map as provided in NRS 517.040.
