

# CERTIFICATE OF LOCATION <sup>117953</sup>

## LODE CLAIM

THIS IS TO CERTIFY that the CG #9 lode mining claim was located by:

Said claim is located in the NE/4 of Sec.       , Twp.        North, Range        East.  
SE/4 of Sec.       , Twp.        North, Range        East.  
NW/4 of Sec. 26, Twp. 35 North, Range 51 East.  
SW/4 of Sec.       , Twp.        North, Range        East.

To tie this claim to the Public Survey, begin at the Southeast corner of Section 33, Township 35 North, Range 51 East, Mount Diablo Meridian, thence 11000 feet North and 6000 feet East to the Northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Northerly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast corner:
