CERTIFICATE OF LOCATIONLODE CLAIM

THIS IS TO CERTIFY that the CG # 32 lode mining claim was located by:

NW/4 of Sec. 26, Twp. 35 North, Range 51 East.
SW/4 of Sec. 26, Twp. 35 North, Range 51 East.

To tie this claim to the Public Survey, begin at the Southeast corner of Section 33, Township 35 North, Range 51 East, Mount Diablo Meridian, thence 6500 feet North and 8400 feet East to the Northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 10 feet from the location monument in a Northerly direction and 1490 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
