CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT # 2 lode mining claim was located by:

To tie this claim to the Public Survey, begin at the N corner of Section
2, Township 33 North, Range 50 East, Mount Diablo Meridian,
thence 1700 feet South and 1500 feet East to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 1490 feet from the location monument in a Easterly direction
and 10 feet in a Westerly direction, together with 300 feet
on each side of the center of the ledge for the entire length of the claim.
