LODE CLAIM

SW/4 of Sec. 2, Twp. 33 North, Range 50 East.

To tie this claim to the Public Survey, begin at the N¹ corner of Section
2, Township 33 North, Range 50 East, Mount Diablo Meridian,
thence 3500 feet South and 1500 feet East to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 750 feet from the location monument in a Easterly direction
