CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT # 103 lode mining claim was located by:

SE/4 of Sec. 14, Twp. 33 North, Range 50 East.  
NW/4 of Sec.       , Twp.        North, Range        East.  
SW/4 of Sec.       , Twp.        North, Range        East.

To tie this claim to the Public Survey, begin at the Northeast corner of Section  
15, Township 33 North, Range 50 East, Mount Diablo Meridian,  
thence 2700 feet South and 5400 feet East to the Northeast  
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,  
extending 1490 feet from the location monument in a Northerly direction  
and 10 feet in a Southerly direction, together with 300 feet  
on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe  
monuments firmly set in the ground and bearing applicable monument designation. The  
description of such claim is: Beginning at the Northeast Corner:
