CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT # 127 lode mining claim was located by:

thence 300 feet North and 1800 feet East to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
