LODE CLAIM

thence 6850 feet South and 3525 feet West to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 10 feet from the location monument in a Northerly direction
and 1490 feet in a Southerly direction, together with 300 feet
on each side of the center of the ledge for the entire length of the claim.
