LODE CLAIM

To tie this claim to the Public Survey, begin at the Northeast corner of Section

thence 8350 feet South and 1125 feet West to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
