CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT # 179 lode mining claim was located by:

SW/4 of Sec. 26, Twp. 33 North, Range 50 East.

To tie this claim to the Public Survey, begin at the Northeast corner of Section
23, Township 33 North, Range 50 East, Mount Diablo Meridian,
thence 8350 feet South and 2325 feet West to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 1490 feet from the location monument in a Northerly direction
and 10 feet in a Southerly direction, together with 300 feet
on each side of the center of the ledge for the entire length of the claim.
