CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT # 205 lode mining claim was located by:

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 750 feet from the location monument in a Northerly direction and 750 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
