CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT # 209 lode mining claim was located by:

NW/4 of Sec. , Twp. North, Range East.
SW/4 of Sec. , Twp. North, Range East.

To tie this claim to the Public Survey, begin at the Northeast corner of Section 17, Township 35 North, Range 51 East, Mount Diablo Meridian, thence 0 feet North and 5300 feet East to the Northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Northerly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
