CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CI #228 lode mining claim was located by:

33, Township 35 North, Range 51 East, Mount Diablo Meridian,
thence 5500 feet North and 5400 feet East to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 1490 feet from the location monument in a Northerly direction
